

Exceptional Social and Medical Parent's statement

Exceptional social and medical criterion:

The Council's Executive Director of Supporting People may give priority to applicants who can demonstrate that admission to school is necessary on the grounds of professionally supported exceptional social and medical need.

In making your case you should:

- 1) Have read Camden's Exceptional Social and Medical Policy
- 2) Provide evidence that your child has exceptional social or medical needs. The evidence needs to be from a doctor or a consultant, social worker or therapist and must be dated within the last six months
- 3) You and the professional need to demonstrate why the child's needs can be met only a specific school.

Camden has an advisory panel of experts which consists of a consultant paediatrician, a senior social worker and an education psychologist who will make a recommendation to the Admissions Service. The advisory panel is there for advice and the Council reserves the right to accept or reject the advice offered. The advisory panel does not vote nor does it need a majority decision to award social and medical status and will only consider the information you submit at the time of the meeting. Neither the advisory panel nor the admissions service will contact other professionals to seek information.

Social and Medical status can only be given for community schools – if you are applying for a faith, an academy or a free school you should contact the school to see if they have this admission criteria. (Please note not all schools do).
