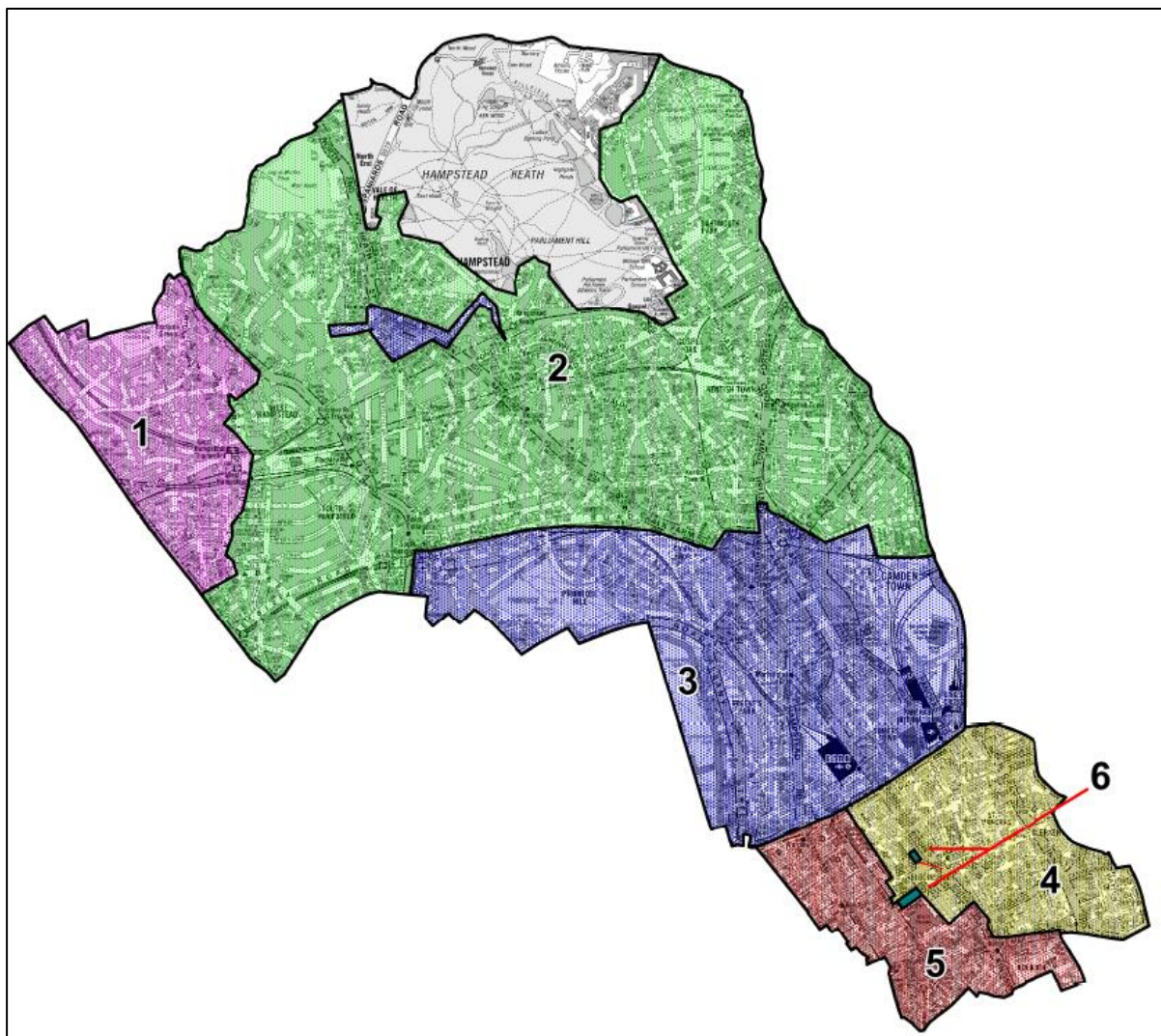


## PROPOSED CHANGES TO PAID-FOR PARKING CHARGES

The London Borough of Camden is proposing to amend paid for parking charges and include an additional surcharge for diesel vehicles. We anticipate that this will help us to improve the air quality in Camden. We also anticipate that it will contribute to addressing the health impact of vehicle emissions by discouraging inessential car use and encouraging more sustainable modes of transport.

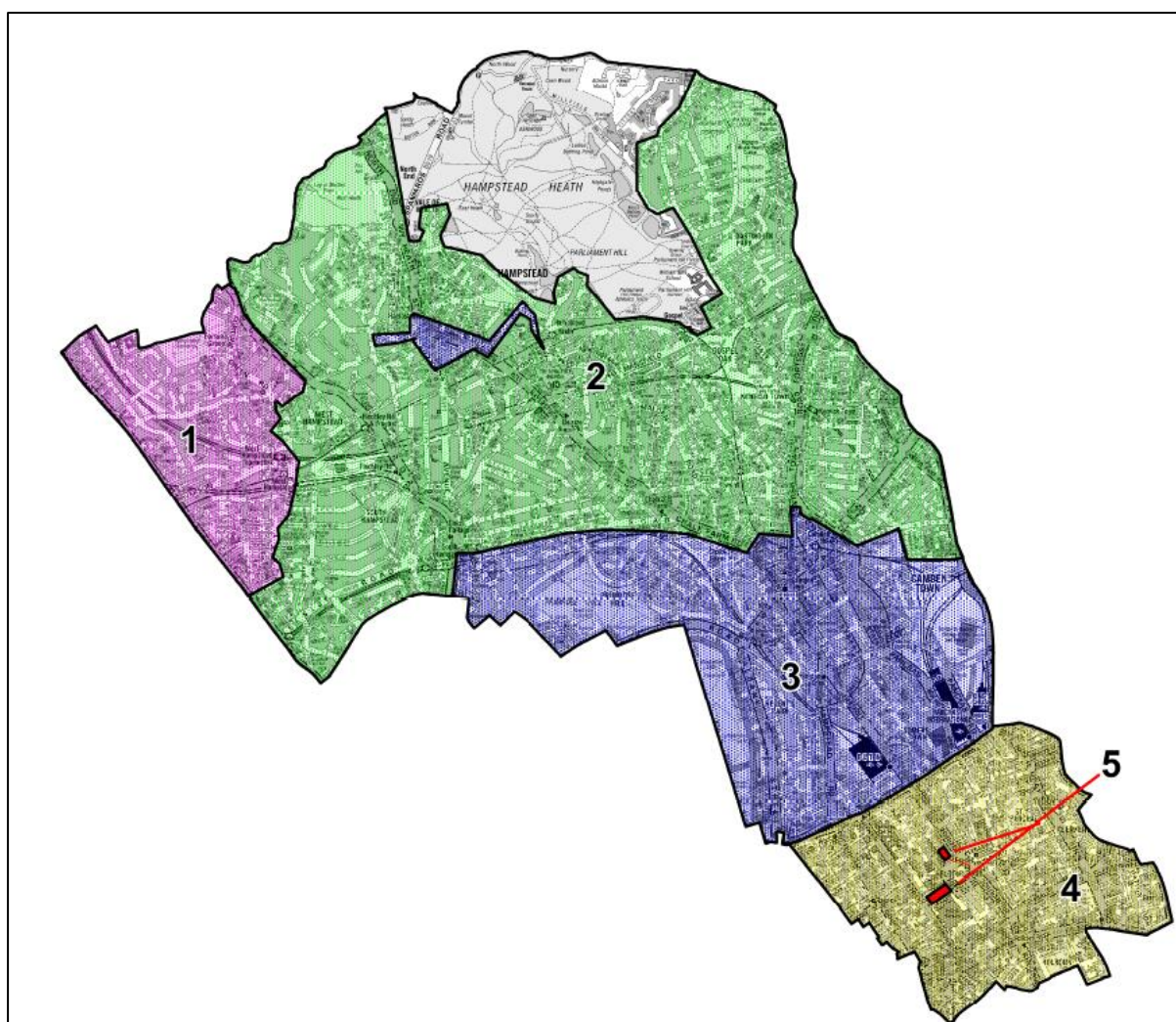
