# Demolition methods: independent review

We've listened to your concerns about the impacts of air quality and dust on residents' health while demolition works are underway. We urged HS2 to undertake an independent peer review of demolition methods that use the protective screen, such as those used to demolish the Eskdale and Ainsdale buildings.


## Have your say on Euston

# Walkabout of Euston

In January we welcomed the HS2 Chief Executive and other decision-makers on a walkabout of Euston to help address how we can make the area safer, greener and easier to navigate.

A number of improvements for the area were agreed with HS2, and we will engage with residents on these improvements in the coming months.

# Road closures in your area

**Existing closures**: Pedestrian access will remain open while the junction of Stanhope Street and Varndell Street is closed until late February.

The west side of Cumberland Market will remain closed until mid-February.

Upcoming closures: From 10 February to 6 March, 15 meters of the southbound lane of Stanhope Street in the junction with Park Village East will be closed.
