Dear Residents

Thank you for your understanding and patience during the ongoing works at Maitland Park Estate. We hope that you are keeping safe and well during this challenging time.



## **Progress to Date**

Below is a list of works undertaken on the Maitland Park site since our last newsletter in June:

- Pile cropping to all blocks has now been completed, meaning that noisy works for this activity have now ceased
- The concrete frame at Aspen Villas is progressing well, with the third floor now poured and the fourth-floor columns and walls are now underway
- The concrete frame to Aspen Court has commences with half of the first floor poured
- The concrete frame to Grafton Terrace has commenced, with part of the first floor poured and verticals started
- The piling works have been completed at Grafton House and the ground has been prepared for the floor slabs

## **Forthcoming Construction**

Over the next four weeks we will be carrying out the following works:

- Concrete frames to all blocks: We will continue the RC Frame concrete falsework and concrete pours. During this time residents can expect increased vehicular movements of concrete lorries, and rebar deliveries.
- External walls installation commencing on Aspen Villas: We will be commencing the external brickwork at ground level and external SFS wall installation.



- **Scaffold commencing on Aspen Villas:** We will be commencing the ground floor backfill, which will allow the commencement of our external scaffolding system.
- **Window installation on Aspen Villas:** Window installation will commence at Aspen Villas. Residents can therefore expect increased vehicular movements during our ongoing scheduled deliveries.
- Vehicle movements: Increased vehicle movements can be expected within the permitted delivery hours as the trades increase as noted above. These are being managed internally via a daily booking-in process.

**External works** G.NETWORK is responsible for the Fibre Broadband Network expansion works that their contractor ReachActive are completing at Maitland Park Villas that started on 28<sup>th</sup> April. *Bouygues UK does not have any participation or responsibility on this work*. If you have any concern, please contact Camden Council or G Network 0800 033 4003. The works on Maitland Park Villas are due to be completed by 19<sup>th</sup> June, 2021.



**Saturday Work** – To ensure that our works are completed in a safe and timely manner we will be recommencing work on Saturdays between the hours of 8am and 1pm, for which permission has been granted by the Council. We apologise for any inconvenience or disruption that this may cause and thank you for your patience.

**Laptops** – Bouygues are proud to confirm that at present we have donated 40 laptops to the local schools of Camden, worth a total of £8,000.
