Ongoing works on Maitland Park Estate

Dear Residents

We would firstly like to take this opportunity to thank you for your understanding and patience during the ongoing works at Maitland Park Estate. Below is a list of works undertaken on the Maitland Park site since we commenced on the 15th March:

- We installed our site offices in the Grafton Green area
- Temporary power has been installed to the Grafton site
- A piling safety platform has been installed at the Grafton Terrace site
- We have installed over 200 piles in the ground to form the foundations for the two new blocks on the Aspen site. (see image to the right showing installed piles in orange on the design model).

Over the next four weeks we will be carrying out the following works:

• We will be starting the piled foundations to Grafton Terrace and Grafton House - Foundations provide support for structures, and piled

foundations are deep foundations. To install the piled foundations we will continue to use a piling rig (see image to the right).

This rig will drill the piles through the ground to give the necessary support for the construction of the new homes. The increased noise from the piling rig should only last for three weeks, and during this time there will also be an increase in concrete deliveries to Grafton Terrace and 'Muck Away' trucks to and from the site.

- We will complete the remaining piled foundations on the Aspen site - As we are completing these works residents should notice reduced noise from the Aspen site.
- Groundworkers will start the installation of concrete slab foundations on Grafton Terrace and Aspen Site Once the piled foundations have been completed, a concrete slab foundation will be formed by pouring concrete directly onto the ground. These works will result in additional concrete deliveries and Muck Away trucks to and from the site.
- Start of drainage installation at Aspen Villas and Aspen Court These works will result in additional deliveries and Muck Away trucks to and from the site.
- We will be erecting a tower crane on the Aspen site in mid-May
