### Camden seeks assurance as construction restarts

In keeping with guidance from Public Health England on COVID-19, we paused delivery of your monthly newsletter. We are pleased to restart this newsletter with the June edition. A number of you have raised concerns about HS2 works restarting, in particular more noise and dust when you are being asked by the Government to stay at home. We share these concerns, so Councillor Danny Beales has written to HS2's CEO Mark Thurston to ask HS2 do everything possible to reduce the impact of construction at this challenging time.

### Noise insulation temporarily paused

Due to the Covid-19 outbreak, HS2 have temporarily suspended works to install additional noise insulation. Though we are keen for these works to continue, your safety remains our top priority and so we have asked HS2's contractors to provide a clear outline of how they plan to meet safe social distance guidelines going forward. We know how important it is for many of our residents to receive improved noise insulation to help manage noise and pollution from the nearby construction works, please let us know if you would like noise insulation works once they resume by emailing highspeed2@camden.gov.uk.

# Camden stands firm against HS2 lorry routes

We are committed to ensuring HS2 reduce the number of large construction vehicles (HGVs) in your area. Last year we secured a 10mph speed restriction for vehicles weighing over 7.5 tonnes on Varndell and Harrington Street.

Since then, HS2 have appealed to the Government over approved routes to and from their construction sites, seeking access to: the Adelaide Road site which would impact the northern part of Camden High Street; and the Euston Approaches site which would impact Regents Park Estate and Harrington Square.

We believe that these routes present an unacceptable risk to pedestrians and unreasonable disruption to surrounding homes. To support your community, we are standing firm against HS2 and contesting their appeal. We have recommended alternative and less disruptive access routes to Adelaide Road, along with conditions for using the Euston Approaches, including: one-way road traffic for HS2 vehicles on a number of roads; and prohibiting HGVs during school pick up and drop off times. ### New and improved Pangbourne allotments

The new allotments have only been possible through a £45,000 Camden Giving grant, which Regents Park Gardening Club applied for last year. The project has been further supported by ward councillors who offered an extra £20,000 in local Community Infrastructure Levy funds. #### £650K secured for Drummond Street neighbourhood revival

Plans to transform Drummond lighting, new construction have been awarded £650,888 through the HS2 Business and Local lighting, new construction street furniture. This follows extimpacted by HS2 construction have with local residence who told us that see improvements.

The plans drawn up by Camden and Euston Town Business Improvement District, include improved pedestrian access, better lighting, new communal space and street furniture.

To further support the project Euston Town Business Improvement District have pledged an additional £160,000. The improvement works be completed in three phases with the first expected to finish in autumn 2021.

## HS2 construction works

From mid-June HS2 will be carrying out water diversion and sewer construction works on Harrington Street. The water diversion works will take six weeks, split into two three-week phases, with a lane closure to manage traffic flow. The sewer works will need a full road closure from the end of July until January 2021.
