Dear parents,

This pack is for officially changing any forenames (first and middle names) of your child within twelve months of the birth registration.

The form 'certificate of name given in baptism (or not in baptism)' can be used if you wish to change any forename(s) of your child from those you registered him/her in at the register office and have since given a Christian baptism to them in the first twelve months from the registration or just want to change any of the forename(s). The baptism must have been in the new names you wish your child to be known as. The vicar or minister of the church needs to complete the form. They may charge you for this. We enclose an example of a completed form for reference.

If the child is not baptised you will need to complete the form using the example provided to help you.

Please be advised that on the full birth certificates thereafter, your child's existing name will still appear in space 2. The updated name will appear in space 17 'name given after registration'. Please also note that you can only change any forename(s) or your child using these forms once, never on multiple occasions. These forms do not apply if you are correcting a forename (for example, if you spelt it incorrectly at the original registration). In this case, you must apply for a correction. Space 17 amendments are only for (i) when you change your mind about your child's forename(s) or (ii) for recording baptismal name(s) which were not given at the register office on the original registration.

Please post us your completed form together with the completed section below and any cheques as payment. We will process your request within 15 working days. If you need this urgently you can ask for an express service which costs £18.

The fee for this change of name is £40 for each child with additional £4 for each certificate required (£11 each from 16th February 2019)

The certificate must be produced to the registrar or superintendent registrar who has custody of the register in which the birth was registered.
