### Cracking at Augustus House

You may be aware of reports of cracking in the walls of the Augustus House building. We have written to all residents living at Augustus House to assure them that the building is structurally safe. Resident safety is our first priority and that's why we carried out safety

checks in the building on the night that reports were made by residents. We have also carried out a number of additional checks since, including by an independent assessor who has also confirmed that the building is structurally safe. We are continuing to monitor the building to make sure nothing Changes.

When all our assessments are complete we will be meeting with HS2 to share the findings.

## Road closures near you

**Existing closures:** The road closure in Stanhope Street is expected to reopen again between Mackworth and Varndell Streets in mid-October.

**New closures:** New closures will be introduced further north along Stanhope Street between

Mackworth Street and Granby Terrace in October. A new road closure has also been introduced along Robert Street at the junction with Stanhope Street. This closure will move towards Hampstead Road in three phases. Thames Water will carry out further emergency works on Eversholt Street from the end of September.

## HS2 construction works in your area

**We are committed to doing everything we can to help reduce the impact of HS2 in your neighbourhood. You can also find regular works updates online at [HS2inCamden.co.uk](https://www.hs2incamden.co.uk)**

Works to remove the basement of the Ainsdale building continue and are expected to be completed in September. HS2 Ltd. are now undertaking preparatory works to demolish the Eskdale, Silverdale and Granby Terrace buildings. Demolition of these buildings is due to begin in October, and expected to continue for up to eight weeks. Works to demolish Silverdale are expected to continue for a period of 12 weeks. Lorry vehicles will be entering and leaving the estate via Granby Terrace Bridge. Night-time scaffolding works are due to take place near Stalbridge House during the weekends of 12, 19 and 26 October.
