The London Borough of Camden authorises the stopping up of the areas of highway described in the First Schedule to this Order and shown on the attached drawing number 22706201-SU-007, solely in order to enable the development described in the Second Schedule to this Order, to be carried out in accordance with the planning permission, granted under Part III of the Town & Country Planning Act 1990, by the London Borough of Camden on the 5 April 2015 under reference 2015/5068/P, for the works described in the Second Schedule to this Order.

1. This Order shall come into force on 29 September 2016 and may be cited as the Stopping Up of Highways (London Borough of Camden) (Number 2) Order 2016.
