
### Year 1 - Recap

In the first year of the Panel, members have helped to:

- Design a future Public Information Campaign;
- Evaluate proposals for the Prince of Wales segregated cycle lane project;
- Input into the relaunch of the Camden Climate Fund; and
- Suggest approaches to increase signatories of the Camden Climate Pledge for businesses.




#### Progress dashboard

To provide more visibility and tangible metrics showing the extent of progress made against key commitments in the Climate Action Plan, the following dashboard has been produced to offer a snapshot of progress. This was a direct recommendation of the Camden Climate <u>Citizen</u> <u>Panel</u>.

Borough-wide direct and consumption emission data is taken from national datasets, published 18 months and 3 years after the conclusion of the year respectively, due to the complexity of the data gathering requirements. As such, the impact of projects tackling emissions will not be immediately accounted for in emissions reduction. Consumption emission data is derived from national datasets and surveys of a small number of Camden households. The data accuracy is <u>limited, and</u> discussed later in the report.

The period of time the data relates to is stated against each metric in the dashboard. For future years of the Climate Action Plan review, comparison will be made against the baseline established from year 1 of the delivery of the Plan.

In addition to metrics provided in the dashboard, more information is available within the key achievements section for each vision area. The Council is committed to continuing to improve the way we communicate about climate action in Camden.



- The <u>School Sustainability Peer Support Network</u> was established in partnership with Think & Do. The network is an online space for teachers to share experiences and ideas around sustainability initiatives in schools.
- The <u>Sustainability Ambassadors programme</u> was established in partnership with Think & Do and UCL, designed to give students an introduction to climate action in communities.
- The Council's <u>Climate Crisis</u> webpages were launched, giving residents access to high-quality information about climate change and what steps can be taken to reduce their carbon footprint.
- The first PUNL Community Energy Fund project came to fruition at the beginning of May when pupils from
  Parliament Hill School planted a "feminist orchard". Thirty students from Years 7 to 9 helped plant 11 fruit trees,
  laid wildflower turf and dug a pond.
- Residents have been kept up to date with the improvements to cycling and walking in the Borough since March 2020 through an <u>online map</u> and <u>commonplace page</u>.
- Local Councillors received training on low-carbon development and how to assess the suitability for approving
  applications, with respect to the sustainability and energy. Local Councillors were also invited to join Climate
  Capability Training delivered by London Councils and London Environment Directors Network.
- Camden's <u>Reduction and Recycling Plan</u> was published and continues to steer the Council's strategy for driving down waste production in the Borough.
- The Camden Refill Station was established as a regular market stall at Queen's Crescent Market.
- Camden launched the <u>Community Climate Action grant</u>, with up to £5,000 for community led carbon reduction projects.
- 1058 people (2020/21) were given advice by the <u>Green Camden Helpline</u> on home energy and Climate related issues. Callers were saved a collective £63,840 from their energy bills through support received.
- Camden's first 'Library of Things' opened at Kentish Town library in the Summer of 2021, helping to reduce indirect carbon emissions in Camden.
- The <u>Camden Renewal Commission</u> and Camden Giving launched the <u>We Make Camden Kit</u> giving money and support to Camden residents and community groups who have great ideas for their communities. The key missions these grants are looking to support include project that address food poverty and sustainability, and health and sustainability of estates.
- January saw the publication of a special edition of the Camden New Journal with a four-page community-written 'Camden Future Journal' wraparound and launch of the <u>Visioning Camden 2030</u> initiative. People who work, live and study in Camden were invited to visualise what our borough could be like in 2030 once we have addressed the climate and social inequality crisis.




