
A look back - Two Years of the Panel

Camden Climate Citizen Panel – first of it's kind, learn by doing approach


 Role of the panel – initial guise to scrutinise, co-design & collaborate. Required some reworking

Opportunity to 'trailblaze' engagement with your feedback

To identify areas of the Climate Action Plan where the Panel can support organisations, including the Council, to deliver projects reducing carbon emissions. The Panel will also identify opportunities to facilitate Climate Action by Camden citizens.
