#### MIDLAND ROAD, NW1

Revoke the bus lane in its entirety.

#### **HIGHGATE ROAD, NW5**

Re-designate operative hours of the southbound bus lane between Burghley Road and the junction with Fortess Road / Kentish Town Road as Monday to Fridays 7-10am and 4-7pm and Saturdays 10am–7pm. Exemptions apply for taxis, pedal cycles and dial-a-ride.

#### **BLOOMSBURY PLACE / BLOOMSBURY SQUARE / VERNON PLACE, WC1A**

Extension of eastbound bus lane from the junction with the west side of Bloomsbury Square to the junction with Southampton Row. Operational hours – at all times. Exemptions apply for taxis, pedal cycles and dial-a-ride vehicles.

#### THANET STREET / HASTINGS STREET, WC1H

Conversion of the residents permit parking place on the north-east side closest to the junction with Hastings Street. to three business permit parking spaces. Residents permit spaces will be replaced in Hastings Street on the north-west side by extending the parking place between the junctions with Thanet Street and Sandwich Street with the two disabled parking spaces adjacent to each end to be relocated to the north-east and southwest accordingly.




