#### **HUNTLEY STREET (between the junctions with Grafton Way and University Street)**

Vehicular traffic to proceed in one direction, from north to south, in this section of Huntley Street. Revocation of all parking places in this section of the street (2 "paid-for" parking places of 31 and 23 metres length, 1 loading bay of 15 metres length).

Designation of two loading bays of 10 metres length, one the north-east side approximately 30 metres north-west of the junction with University Street, the other on the south-west side approximately 5 metres north-west of the same junction

Designation of a 24-hour waiting prohibition in this section of Huntley Street (other than where loading bays are designated)

Designation of an additional 24-hour loading prohibition from the junction with Grafton Way southwards for a distance of approximately 35 metres.

#### **UNIVERSITY STREET**

Removal of a 5 metre section of the paid-for parking place on the south-east side, immediately north-east of the junction with Huntley Street. Designation of a 24-hour prohibition on waiting on the south-east side from the junction with Huntley Street for a distance of approximately 12.5 metres


