#### The Camden (Harmood Street) (Modification No. 1) Experimental Traffic Order 2021

Notice is hereby given that the Council of the London Borough of Camden made the above mentioned order on 25 October 2021 under Section 9 of the Road Traffic Regulation Act 1984, as amended. The order will come into force on 4 November 2021. This order modifies the Camden (Harmood Street) Experimental Traffic Order 2021 which came into force on 28 January 2021. The general nature and effect of the modification order is as follows:

HARMOOD STREET – conversion of the paid-for parking place outside nos. 35-39 Harmood Street to "shared-use" allowing "CA-F" permit holders to use the parking place.

The Council will be considering in due course whether the provisions of the experimental order should be continued in force indefinitely. Within a period of six months beginning with the date on which the experimental order came into force or, if the order is varied by other orders or modified pursuant to section 10 (2) of the Road Traffic Regulation Act 1984, beginning with the day on which the variation or modification or the latest variation or modification came into force, any person may object to the making of an order for the purpose of such indefinite continuation.



#### **Statement of Reasons**

In response to feedback received via the Harmood Street ETO this order will convert 17.1 meters of Pay by Phone parking spaces outside no. 35-39 Harmood Street to Shared Use Resident and Pay by Phone parking spaces. There is significant demand for kerbside space in this area and designating this bay for use by CA-F permit holders and for Pay by Phone will increase the availability of parking for local residents and enable visitors to the area to park.
