The general nature and effect of the order will be to revoke the existing parking places located in the northeastern perimeter of Cartwright Gardens comprising two motorcycle and two paid-for parking places and designate the following parking places from north-west to south-east:

Motorcycle parking place - 12.6m length

Electric vehicle charging point – 13.1m length

Paid-for parking place – 17.7m length

Prohibitions on waiting, including for the purposes of loading, will apply at any time along the south-west side of the north-eastern perimeter and along the north-east side for approximately 12m south-eastwards from the junction with Hastings Street and for approximately 50m north-westwards from the junction with Leigh Street.

Notice is also given under s. 90C of the Highways Act 1980 of the council's intention to construct a flat-top road hump approximately 11m long and constructed to no more than 100mm height across the north-east perimeter of Cartwright Gardens at a point corresponding to the entrance to the gardens. 
