# The Camden (Waiting and Loading Restrictions) (Civil Enforcement Area) (Amendment No. 148) Traffic Order 2022

Notice is hereby given that the Council of the London Borough of Camden proposes to make the above order under Sections 6 and 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended. The general nature and effect of the order is set out below:

FLAXMAN TERRACE – revocation of the two motorcycle parking places situated in Flaxman Terrace, one sited approximately 50 metres from the junction with Mabledon Place and the other outside Flaxman Lodge. with a waiting prohibition to apply along the lengths of the parking places on Mondays to Fridays from 8.30am to 6.30pm and on Saturdays from 8.30am to 1.30pm.

#### STATEMENT OF REASONS


The order would revoke the designation of two motorcycle parking places in Flaxman Terrace currently sited close to Flaxman Court, a large residential block.

Council officers from various teams have, over recent years, been in discussion with local residents as well as businesses in this road about the air quality and noise issues that were being generated by vehicles using the motorcycle bays. Residents also expressed a desire to see some form of greening measures installed in the street, similar to those introduced elsewhere across the borough.

A public consultation was carried out between 22<sup>nd</sup> July 2022 and 11<sup>th</sup> August 2022, lasting 3 weeks. Consultation letters were distributed to a number of local residential and business properties along the street. Following consideration of responses it has been agreed to progress with the proposal to remove the motorcycle bays. Several other parking places for motorcycles, including secured spaces, are located close to Flaxman Terrace.

There will also be a unique greening opportunity here for the local community that will provide planting and green activities in the form of a planter at one of the site currently occupied by a motorcycle bay should the local community decide they wish to take on the responsibility of maintaining the plants within. This greening opportunity is to be funded through the social value element of the current parking and civil enforcement contract.

The Council of the London Borough of Camden, after consulting the Commissioner of Police of the Metropolis, in exercise of the powers conferred by sections 6 and 124 of and part IV of schedule 9 to the Road Traffic Regulation Act 1984 [1984 c. 27], as amended by section 8 of and part I of schedule 5 to the Local Government Act 1985 [1985 c. 51], and of all other powers thereunto enabling, hereby make the following order:

#### 1. Citation and commencement

This order shall come into force on and may be cited as the Camden (Waiting and Loading Restrictions) (Civil Enforcement Area) (Amendment No. 148) Traffic Order 2022.

### 2. Interpretation

- 2.1 In this order;
- the term "parent order" means the Camden (Waiting and Loading Restrictions) (Civil Enforcement Area) Traffic Order 2012 [L.B.C 2012 No. 1];
- any reference in this order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment;
- unless the context otherwise requires, any expression used in this order which is also used in the parent order shall have the same meaning as in that order.

#### 3. Amendment to Schedule 5 to the parent order

Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into force of this order the parent order shall have effect as though there was omitted from schedule 5 to that order, the items set out in the table of the schedule to this order.
