




BURGESS HILL – the removal of a parking space would enable the construction and use of a vehicular crossover accessing an adjacent property



KINGSGATE ROAD / KINGSGATE PLACE – the orders would improve accessibility to a parking place designated for an individual with disabilities by relocating it to Kingsgate Road from Kingsgate Place. The number of resident permit holders parking places available would be maintained.
