Notice is hereby given that the Council of the London Borough of Camden proposes to make the above orders under Sections 6, 45, 46, 49 and 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended. The general nature and effect of the orders will be to designate disabled parking places either in general or for specific individuals, together with associated changes to existing parking restrictions as set out below:

AGAR GROVE: south side; removal of the westernmost 5 metre section of the permit holders parking place opposite the rear of Gairloch House, Stratford Villas in order to designate a dedicated disabled person's parking place at the location.

FITZROY ROAD: north-west side: removal of the north-easternmost 6.6m section of the permit holders parking place outside no. 44 Fitzroy Road in order to designate a dedicated disabled person's parking place at the location.

ROSEMONT ROAD: south side: conversion of the dedicated disabled person's parking place at the side of no. 291 Finchley Road to parking space for Blue Badge holders.

VALE OF HEALTH: east side: conversion of the disabled person's parking place opposite Vale House to a residents permit holders parking space.







Statement of Reasons

The orders will designate (or revoke where they are no longer required) parking places either for the sole use of residents whose mobility is severely impaired or for the leaving of vehicles in which a valid Blue Badge is displayed.

The proposals meet the objectives of Camden Transport Strategy (CTS) which acknowledges that people who have a disability can have particular difficulties when they are travelling by public transport, and walking and cycling may be difficult, unsuitable, or simply not an option.
