


Over the last two years the borough has implemented a network of nearly two hundred parking bays to support micro mobility in the form of hire E-Bikes and rental E-Scooters as part of the London Rental E-scooter trial. These new modes of transport have enabled people who live and work in the borough to have greater options in how they travel. The bay on Tower Street is one of the busiest locations for these modes of transport. As usage of these modes of transport increases and demand for the parking bays grows, we have seen capacity issues and a small amount of disruption in regard to the bay at the north-western end of Tower Street. At busier times this bay has seen hire vehicles overflowing into surrounding parking bays and the street due to the existing bay being full. This consultation concerns proposals to solve the issues mentioned above by relocating and expanding the bay to the south-eastern end of Tower Street to meet demand.




