Notice is hereby given that the Council of the London Borough of Camden proposes to make the above orders under Sections 6, 45, 46, 49 and 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended. The general nature and effect of the orders will be to designate disabled parking places either in general or for specific individuals, together with associated changes to existing parking restrictions as set out below:

BELSIZE GROVE – re-designate a disabled persons' parking place on the north-west side approximately 15 metres north-east of the junction with Belsize Park Gardens.

BURY PLACE – convert the residents parking place outside nos. 1-12 Russell Chambers to a dedicated disabled person's parking place; convert the Car Club parking place north-west of the junction with Galen Place to a residents parking place

NEW OXFORD STREET – convert the westernmost 6.6 metre section of the residents parking place situated immediately to the east of the junction with Museum Street to a dedicated disabled person's parking place

ST. CUTHBERT'S ROAD – convert a 6.6 metre section of the residents parking place outside no. 23 St. Cuthbert's Road to a dedicated disabled person's parking place





## Statement of Reasons


