


OAKLEY SQUARE (north-west arm) – introduction of 24-hour waiting prohibitions, including for the purposes of loading or unloading at the junctions with Crowndale Road and with Eversholt Street. The restrictions will cover the areas between the junctions and the nearest parking places, with no alteration to those parking places, except on the north-west side where the northernmost 2.7 metre section of the residents parking place closest to the junction with Crowndale Road will be removed.

- 2.1.3 unless the context otherwise requires, any expression used in this order which is also used in the parent order shall have the same meaning as in that order.

3. Amendments to Schedule 1 and 2 to the parent order

- 3.1 Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into force of this order the parent order shall have effect as though;
- 3.1.1 there was substituted for the items set out in relation to the similarly named street in schedule 1 to the parent order, the items set out in table 1 of the schedule to this order;
- 3.1.2 there was included in, or substituted for items set out in relation to similarly named streets in schedule 2 to the parent order, the items set out in table 2 of the schedule to this order;

- 3.1.3 there was omitted from schedule 5 to the parent order, the items set out in table 3 of the schedule to this order;
- 3.1.4 there was included in schedule 5 to the parent order, the items set out in table 4 of the schedule to this order.
