## The Camden (Parking Places) (CA-X) (Amendment No. X) 2023

Notice is hereby given that the Council of the London Borough of Camden proposes to make the above orders under sections 45, 46, 49 and 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.

The general nature and effect of the order will be to re-designate parking restrictions in the streets below and to impose a requirement to obtain a parking permit in order to leave vehicles in the following streets in the Elm Village Area on Mondays to Fridays between 8.30am and 6.30pm (controlled hours). The streets form a contiguous area with entry points from Barker Drive and Camley Street (controlled area) and this order is being progressed to rectify deficiencies in the order currently designating parking controls in the "CA-X" controlled parking zone.

The requirement does not apply to "private" parking spaces which will remain individually signed by being demarcated from the carriageways by means of solid, white lines or upright signage. Areas already designated with a prohibition against waiting at all times by vehicles and marked with double yellow lines will remain unaltered. Vehicles in respect of which a permit has been issued may also be left during the controlled hours in parking places in Barker Drive and Camley Street where the permit identifier "CA-X" appears on the adjacent sign.

#### STREETS AFFECTED BY THESE PROPOSALS Rossendale Way, Bergholt Mews, Weavers Way, Ploughman's Close, Crofters Way, Reapers Close.

Resident permits will be available, according to the Council's terms and conditions, with 12 or 6-month validity periods with charges graded according to the vehicle's CO2 emissions. Up to 3 vehicles may be registered to a residents permit although only one vehicle is permitted to be parked in the permit controlled area or controlled parking place at any given time. An additional charge is applicable to second or third vehicles registered to a permit and a surcharge is applicable to any diesel-powered vehicle registered to the permit. Lower charges apply in respect of electrically powered vehicles and motorcycles.

Residents will be able to obtain visitors' permits at hourly rates enabling visitors' vehicles to be left in the controlled area or controlled parking places for up to 4 hours during the controlled hours, up to a maximum of 480 hours per year. Visitors permits may also be obtained for a daily period up to a maximum of 10 per year. Permits are also available to qualifying businesses.

Permit charges are listed below:

#### **CHARGES FOR RESIDENT'S PERMITS**

Tariff 1A - applies to vehicles with CO2 emissions rated up to 120g/km registered after 1 March 2001

Tariff 1B - applies to vehicles with CO2 emissions rated between 121g/km and 150g/km registered after 1 March 2001 or, in the case of vehicles first registered prior to 1 March 2001, with an engine capacity between 0 and 1,299cc.

Tariff 2 - applies to vehicles with CO2 emissions rated between 151 and 185g/km or, in the case of vehicles first registered prior to 1 March 2001, with an engine capacity between 1,300 and 1,849cc.

Tariff 3 - applies to vehicles with CO2 emissions rated between 186 and 225g/km or, in the case of vehicles first registered prior to 1 March 2001, with an engine capacity between 1,850 and 2,449cc.

Tariff 4 - applies to vehicles with CO2 emissions rated over 225g/km or, in the case of vehicles first registered prior to 1 March 2001, with an engine capacity of 2,450cc or over.

#### STATEMENT OF REASONS

It is proposed to formally incorporate Rossendale Way, Blakeney Close, Bergholt Mews, Weavers Way, Ploughmans Close, Crofters Way and Reapers Close within the existing traffic management order (TMO) for the CA-X CPZ to discourage inessential car journeys to the area by providing less parking opportunities for non-permit holders. This proposal was widely supported during a public consultation undertaken in February / March 2022. Of those that responded to the consultation, 61% were in favour of including the seven streets in the CPZ.

In addition to aligning with stakeholder views, it is anticipated that the proposals if delivered will contribute to delivering a number of Camden Council objectives including:

- The Camden Transport Strategy (2019 2041) objective of reducing and mitigating the impacts of transport based emissions;
- The Camden Clean Air Strategy 2019-2034 which ommits the Council to achieving the revised World Health Organization (WHO) air quality guidelines for NO2, PM10 and PM2.5 boroughwide no later than 2034.
- Camden Climate Action Plan, 2020 2025 vision of achieving a net zero Camden by 2030.

This proposal also brings these seven streets into a controlled parking zone which is consistent with the approach taken for all the roads in the borough where Camden Council is the highway authority.

The Council of the London Borough of Camden after consulting the Commissioner of Police of the Metropolis, in exercise of powers conferred by sections 45, 46, 49 and 124 of and Part IV of schedule 9 to the Road Traffic Regulation Act 1984, as amended by section 8 of and Part I of Schedule 5 to the Local Government Act 1985 and Part 6 of the Traffic Management Act 2004 and all other powers thereunto enabling, hereby make the following Order:

# 1. Citation and commencement

1.1 This order shall come into force on and may be cited as the Camden (Parking Places) (CA-X) (Amendment No. X) Traffic Order 2023.

## 2. Interpretation

- 2.1 In this order:
- the term "parent order" means the Camden (Parking Places) (CA-X) Traffic Order 2012 [L.B.C 2012 No. 20];
- 2.1.2 any reference in this order to any other order or enactment shall be construed as a reference to that order or enactment as amended, applied, consolidated, reenacted by or as having effect by virtue of any subsequent order or enactment;
- unless the context otherwise requires, any expression used in this order which is also used in the parent order shall have the same meaning as in that order.

## 3. Amendments to parent order

- Nothing in this article shall prejudice the validity of anything done or any liability incurred in respect of any act or omission before the coming into force of this order.
- 3.2 The parent order shall have effect as though;
- 3.2.1 the following term was included in Article 2:

"map schedule" means the map appended to this order which identifies areas where vehicles or motorcycles may be left, subject to the provisions of this order, in respect of which a residents', visitors', business, motorcycle or electric vehicle permit has been issued.

3.2.2 the following sub-article was included following Article 4.2

"4.2A the area identified in the map schedule may be used, subject to the provisions of this order, for the leaving during the controlled parking period only of such vehicles or motorcycles in respect of which a valid permit has been issued under the provisions of Articles 6, 7, 8, 9 or 10 of this order."
