## The Camden (Permit Parking Places for Electric Vehicles) (No. 1) Traffic Order 2023

Notice is hereby given that the Council of the London Borough of Camden proposes to make the above order under Sections 6, 45, 46, 49 and 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended. The general nature and effect of the Orders would be to designate parking places at the locations below for the sole purpose of recharging battery powered vehicles in respect of which a residents' permit valid within the local Controlled Parking Zone has been issued. Battery charging circuitry is installed in adjacent lamp columns and vehicle batteries must be recharging at all times whilst the vehicle is waiting in the parking place. The parking places will be restricted at all times. On completion of the charging cycle, or following a maximum parking period of 12 hours, the vehicle must be removed from the bay.
