#### The Camden (Prescribed Routes) (No. 5) Traffic Order 2023

Notice is hereby given that the Council of the London Borough of Camden proposes to make the above orders under Sections 6 and 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended. The general nature and effect of the order will be to permit pedal cycles to travel "contraflow" along Drummond Crescent and Doric Way. Cyclists would be permitted to travel from west to east along Drummond Crescent and from north-east to south-west along Doric Way.




#### The Camden (Prescribed Routes) (No. 6) Traffic Order 2023

#### STATEMENT OF REASONS

The overarching aim of the Cycle Permeability programme is to help overcome barriers to cycling. Many streets in the borough are one-way and links between streets on desired routes and Camden's cycle network are often severed by infrastructure, traffic restrictions or highly trafficked major roads. The Cycle Permeability programme aims to make more Camden streets more accessible to cyclists and provide better connections and links through measures such as adding two-way cycling on one-way streets and cut-throughs at physical road closures. A number of such permeability improvements for cyclists have been made in recent years at various locations across the borough.

The proposals for Doric Way and Drummond Crescent will allow cyclist to travel each way along both streets and link with Churchway thereby offering alternative movements to and from Euston Road.

The Council of the London Borough of Camden, after consulting the Commissioner of Police of the Metropolis, in exercise of the powers conferred by sections 6 and 124 of and part IV of schedule 9 to the Road Traffic Regulation Act 1984 [1984 c. 27], as amended by section 8 of and part I of schedule 5 to the Local Government Act 1985 [1985 c. 51], and of all other powers thereunto enabling, hereby make the following order:

#### 1. Citation and commencement

1.1 This order shall come into force on and may be cited as the Camden (Prescribed Routes) (No. 6) Traffic Order 2023.

#### 2. Interpretation

- 2.1 Any reference in this order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
- <sup>2.2</sup> In this order, the term "pedal cycle" has the same meaning ascribed to it by the Traffic Signs Regulations and General Directions 2016 [S. I. 2016 No. 362].

#### 3. Revocation of existing order

- 3.1 Nothing in this article shall prejudice the validity of anything done or any liability incurred in respect of any act or omission before the coming into force of this order.
- 3.2 The Camden (Prescribed Routes) (No. 2) Traffic Order 1965 [G. L. C. 1965 No. 52] is hereby revoked.

#### 4. Restrictions

- 4.1 No person shall cause any vehicle to proceed in Doric Way in any direction other than from south-west to north-east.
- 4.2 No person shall cause any vehicle to proceed in Drummond Crescent in any direction other than from east to west.

## 5. Exemptions

- 5.1 Nothing in Article 4 shall apply in respect of;
- 5.1.1 anything done with the permission of a police constable or traffic warden in uniform;
- 5.1.2 a vehicle being used for police, fire brigade or ambulance service purposes;
- 5.1.3 a pedal cycle;
- 5.1.4 any person causing any vehicle to proceed in accordance with any restriction or requirement indicated by traffic signs placed pursuant to Section 66 or 67 of the Road Traffic Regulation Act 1984.
