Notice is hereby given that the Council of the London Borough of Camden proposes to make the above orders under Sections 6, 45, 46, 49 and 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended. The general nature and effect of the orders are set out below:

FALKLAND ROAD / LEVERTON STREET / LADY MARGARET ROAD – pedal cyclists would be permitted to proceed "contraflow" along the sections of Falkland Road designated as one-way working, i.e. from west to east along the section of Falkland Road lying between its junctions with Leverton Street and Lady Margaret Road and from east to west along the section of Falkland Road lying between its junctions with Leverton Street and Fortess Road. Pedal cyclists proceeding in either direction in Falkland Road will be permitted to proceed straight ahead on reaching the junction with Leverton Street.

- 24-hour waiting and loading prohibitions would be introduced in Falkland Road for a distance
 of approximately 10 metres east from the junction with Fortess Road, for a distance of
 approximately 10 metres each side of the junction with Leverton Street and for a distance of
 approximately 10 metres east from the junction with Lady Margaret Road. Similar restrictions
 would be introduced in Leverton Street and Lady Margaret Road from the junctions with
 Falkland Road, northwards and southwards as far as the existing parking places in those
 streets.
- The Car Club parking place at the side of no. 12 Fortess Road would be relocated 6.6 metres
 eastwards and the adjacent paid-for parking place would be reduced in the length to 10
 metres.
- The residents parking place outside nos. 1-13 Falkland Road would be reduced in length by approximately 3.7 metres at the eastern end.
- The residents parking place outside nos. 2-14 Falkland Road would be reduced in length by approximately 5.2 metres at the eastern end.
- The residents parking place outside nos. 15-41 Falkland Road would be reduced in length by approximately 4.7 metres at the western end and a 4-metre section outside no. 27 Falkland Road would be revoked.
- The residents permit holders parking place at the side of no. 15 Lady Margaret Road would be reduced in length by approximately 5 metres at the eastern end.
- The residents permit holders parking place at the side of no. 13 Lady Margaret Road would be reduced in length by approximately 6 metres at the eastern end.

PRIORY TERRACE / BELSIZE ROAD / ABBEY ROAD – pedal cyclists would be permitted to proceed in a "contraflow" direction along Priory Terrace, i.e. from north-east to south-west.

- 24-hour waiting and loading prohibitions would be introduced from the junction with Abbey Road for approximately 10 metres south-westwards and from the junction with Belsize Road for a distance of approximately 25 metres north-eastwards (north-west side) and for a distance of approximately 15 metres (south-east side). Similar restrictions would be introduced on the north side of Belsize Road for approximately 10 meters either side of the junction with Priory Terrace and in Abbey Road.
- The permit holders parking place, approximately 10 metres length, opposite nos. 37 and 39 Priory Terrace would be revoked and the adjacent dedicated disabled person's parking place would be relocated 5 metres north-eastwards.
- The resident permit holders parking place outside no. 36 Priory Terrace would both be
 extended by 5 metres incorporating the space vacated by the relocation of the dedicated
 disabled person's parking place.




STATEMENT OF REASONS


The overarching aim of the Cycle Permeability programme is to help overcome barriers to cycling. Many streets in the borough are one-way and links between streets on desired routes and Camden's cycle network are often severed by infrastructure, traffic restrictions or highly trafficked major roads. The Cycle Permeability programme aims to make more Camden streets more accessible to cyclists and provide better connections and links through measures such as adding two-way cycling on one-way streets and cut-throughs at physical road closures. A number of such permeability improvements for cyclists have been made in recent years at various locations across the borough.


The proposals for Falkland Road would provide a continuous and safe two-way cycle link on Falkland Road between Fortess Road and Lady Margaret Road, enabling cyclists to access the wider cycle network.

The proposals for Priory Terrace would provide a continuous and safe two-way cycle link on Priory Terrace between Abbey Road and Belsize Road, enabling cyclists to access the wider cycle network.
