#### **CONWAY STREET, GRAFTON WAY:**

#### Reinstatement of two-way working:

Two-way working will be reinstated along the section of Conway Street which lies between its junctions with Grafton Way and Maple Street and along the section of Grafton Way which lies between its junctions with Cleveland Street and Conway Street.

#### Changes to parking restrictions:

A 24-hour prohibition on waiting by vehicles would be introduced in Grafton Way from the junction with Cleveland Street north-eastwards for a distance of approximately 10 metres

Parking place situated on the north-east side of Conway Street would be revoked and parking places designated on the south-west side of Conway Street as follows:

Outside no. 13 – Permit holders "GRN-B" only (Green Badge bay) 6.6 metres length Outside nos. 9 and 11 – Dedicated disabled person's parking place, 8.2 metres length Outside nos. 3 and 5 – Pedal cycles parking place (cycle hire), 5.4 metres length

**STARCROSS STREET:** removal of the south-westernmost 18 metre section of the residents parking place opposite nos. 15 and 16 Starcross Street. A prohibition on waiting by vehicles at all times will apply along this stretch of road.




# Statement of Reasons - Starcross Street

The purpose of this proposal is to provide a new dropped kerb and convert 18m of resident holder parking bay to a no loading or waiting at any time restriction, opposite 15-16 Starcross Street. This is in order to provide access for maintenance and emergency vehicles accessing the construction skills centre and new temporary public open space. The proposal meets the aims of 'Camden Planning Guidance – Public Open Space' by providing an arrangement for the maintenance of the temporary open green space, ensuring that the public space can continue to provide safe and attractive environment that can be enjoyed by their users.

### Statement of Reasons - Conway Street, Grafton Way

The proposed changes would reinstate two-way working along Conway Street (between the junctions with Grafton Way and Maple Street) and along Grafton Way (between the junctions with Cleveland Street and Conway Street). Parking places in Conway Street will be relocated to the western side of the carriageway with the addition of a recently approved dedicated disabled person's parking place. These changes follow the removal of reserved carriageway space for outdoor dining on the eastern side of the Conway Street.
