Notice is hereby given that the Council of the London Borough of Camden proposes to make the above orders under Sections 6, 45, 46, 49 and 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended. The general nature and effect of the orders will be to designate disabled parking places either in general or for specific individuals, together with associated changes to existing parking restrictions as set out below:

BALMORE STREET: south-west side; removal of 17 metres of permit holders parking space to accommodate the relocation of 20 metres of disabled person's parking place outside nos. 41 to 81 Balmore Street; in addition, 6.6 metres provision will be made to designate a dedicated disabled person's parking place at the location, along with the extension of double yellow lines to 10 metres from the junction with Raydon Street to improve visibility.

BROOMSLEIGH STREET: east side; removal of a 6.6 metre section of the permit holders parking place outside no. 29 Broomsleigh Street in order to designate a dedicated disabled person's parking place at the location.

DOWNSHIRE HILL: south-east side; removal of a 6.6 metre section of the permit holders parking place outside no. 49a Downshire Hill in order to designate a dedicated disabled person's parking place at the location.

HARTLAND ROAD: north-west side; removal of the south-westernmost 6.6 metres of the permit holders parking place outside no. 43 Hartland Road in order to designate a disabled person's parking place at the location.

LAYSTALL STREET: north side; conversion of 6.6 metres of double yellow lines outside no. 22 Laystall Street in order to designate a dedicated disabled person's parking place at the location. PATSHULL ROAD: north side; removal of a 6.6 metre section of the permit holder parking place outside no. 65 Patshull Road in order to designate a dedicated disabled person's parking place at the location.

PLATT'S LANE: north-east side; conversion of the dedicated person's parking place outside no. 10 Platt's Lane to a permit holders parking place.

REGENT'S PARK ROAD: south side; removal of the easternmost 6.6 metres of the permit holders parking place outside no. 208 Regent's Park Road in order to designate a dedicated disabled person's parking place at the location.

WINCHESTER ROAD: north-west side; removal of the northwesternmost 6.6 metres of the permit holders parking place opposite nos. 2 to 4 Winchester Road in order to designate a dedicated disabled person's parking place at the location.

WOLSEY MEWS: both sides, designation of 24-hour waiting restrictions from the junction with Gaisford Street northwards for a distance of approximately 34 metres.




STATEMENT OF REASONS


The proposals would see the designation or revocation of disabled parking places either to assist Blue Badge holders in general or for the benefit of specific applicants for individualised parking places. The proposals meet the aims of 'We Make Camden' by improving the quality of life for the user of the proposed dedicated disabled bays, enabling them to live a more independent and active life.


The proposals meet the objectives of Camden Transport Strategy (CTS) which acknowledges that people who have a disability can have particular difficulties when they are travelling by public transport, and walking and cycling may be difficult, unsuitable, or simply not an option.


Additionally, the proposal to introduce 'No Waiting At Any Time' restrictions at the junction of Wolsey Mews with Gaisford Street, in line with Camden's Junction Protection Programmes, and extend this northbound for 33.7m to stop parked vehicles obstructing the main carriageway and the entrance of No. 7 Wolsey Mews, the electric substation and the fire escape passage.








