Notice is hereby given that the Council of the London Borough of Camden proposes to make the above Orders under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended. The general nature and effect of the Orders is as set out below:

# Removal of sections of on-street parking in order to construct 'rain garden' kerb buildouts:

**Parliament Hill** – removal of a 10 metre section of the permit holders parking place on the south-east side outside Nos. 31-36 Parliament Court, Parliament Hill, the kerbside of the build-out facing the centre of the carriageway to be marked with 'at any time' waiting restrictions ('double yellow lines') of the same distance.

**Parliament Hill** – removal of a 10 metre section of the permit holders parking place on the south-east side outside Nos. 13-18 Parliament Court, Parliament Hill, the kerbside of the build-out facing the centre of the carriageway to be marked with 'at any time' waiting restrictions of the same distance.


# Statement of Reasons: Parliament Hill Rain Gardens

The Council are adding more plants and trees across the borough to help minimise water runoff. One way to do this is to increase the amount of on street water storage to soak up water when severe rains arrive, which the climate crisis makes more likely.

To reduce risk in the Parliament Hill area, the Council has identified an opportunity to install two new 'rain gardens'. Rain gardens capture and store rainwater, act as great local habitats for wildlife, and improve the look and feel of an area.

The proposals would remove two 10 metre sections of 'CA-H' permit holders parking space (approximately two car parking spaces) on the south-east side of Parliament Hill outside Parliament Court, so as to provide space for the construction of two kerb build-outs containing these 'rain gardens'.

The kerbside of the each of the two build-outs facing the centre of the carriageway would be marked out with10 metres of 'at any time' waiting restrictions ('double yellow lines'), so as to prevent obstructive parking and facilitate the free flow of traffic in Parliament Hill in the vicinity of the kerb build-outs.

- 3.1.1 there were omitted from Schedule 1 to that Order, the items set out in table 1 of the Schedule to this Order;
- 3.1.2 there were included in Schedule 1 to that Order, the items set out in table 2 of the Schedule to this Order.
