## Wendling and St Stephens Close (WSS) business case preparation

Camden remains committed to delivering our residents' vision and meeting expectations to build new affordable social housing for our WSS residents through the regeneration of Wendling and St Stephens Close.

We have recently completed in line with our annual corporate governance procedures a full review of our existing business case for the WSS regeneration development, the review focuses on continued financial viability and strategies on what the Council's next steps or options are in relation to its preferred option on a delivery model for the scheme to ensure the project delivers on our aim to build new, genuinely affordable homes.

Following a meeting with our Executive Directors, it has been agreed that the Council will continue to work on a delivery strategy proposal that involves a partnership model utilising an experienced construction partner.

As part of this process, we still need to seek approval from the Council's Cabinet. This will also allow us as part of considering this option to deliver bespoke insight sessions to all residents of WSS that explore what a partnership model is, including looking at various approaches and the aims when utilising a regeneration partnership.

# What is happening with Bacton Low Rise?

We are in the process of appointing a development partner for Bacton Low Rise (Bacton phase 2). The new partner is expected to complete the design and build the new development, working together with the Council and wider community stakeholders.

We are in the final stages of concluding the procurement process and contract. We expect to enter contract with the new development partner early next year, with public engagement activities starting shortly afterwards.

#### Timeline

An indicative programme is set out below:

Promote and launch public consultation on estate design	Summer 2024
Set up Construction Working Group	Autumn/ Winter 2024

The developer's delivery programme will be shared with the local community following contract start.
