Coming into force on 28 February 2021

The Council of the London Borough of Camden, after consulting the Commissioner of Police of the Metropolis, in exercise of the powers conferred by sections 6 and 124 of and part IV of schedule 9 to the Road Traffic Regulation Act 1984 [1984 c. 27], as amended by section 8 of and part I of schedule 5 to the Local Government Act 1985 [1985 c. 51], and of all other powers thereunto enabling, hereby make the following order:

#### 1. Citation and commencement

1.1 This order shall come into force on 28 February 2021 and may be cited as the Camden (Prescribed Routes) (No. 5) (Part 2) Traffic Order 2020.

## 2. Interpretation

- 2.1 In this order,
- 2.1.1 any reference to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
- the terms "pedal cycle" and "local bus" have the same meanings ascribed to them as by the Traffic Signs Regulations and General Directions 2016 [S. I. 2016 No. 362].

## 3. Revocations

The London Traffic (Prescribed Routes) (Holborn, St. Marylebone, St. Pancras and Westminster) Regulations 1961 [S. I. 1961 No. 2000] (as amended) shall have effect as thought the items numbered 3, 8, 36 and 37 in the first schedule to those Regulations were omitted.

### 4. Restrictions

4.1 No person shall cause any vehicle proceeding in the street and, if indicated, in the direction specified in column 2 of an item set out in table 1 of the schedule to this order to turn right into the street specified in column 3 of the same item.

- No person shall cause any vehicle proceeding in the street and, if indicated, in the direction specified in column 2 of an item set out in table 2 of the schedule to this order to turn left into the street specified in column 3 of the same item.
- The restrictions set out in Articles 4.1 and 4.2 shall not apply in respect of any class of vehicle set out in column 4 of the respective item.
- No person shall cause any vehicle proceeding in a northerly direction in Tottenham Court Road, other than a pedal cycle or local bus, to proceed past the junction with Great Russell Street and Hanway Street between the hours of 8am and 7pm on Mondays to Saturdays.
- No person shall cause any vehicle proceeding in a northerly direction in Tottenham Court Road, other than a pedal cycle or local bus, to proceed past the junction with Windmill Street and Store Street, between the hours of 8am and 7pm on Mondays to Saturdays.
- No person shall cause any vehicle proceeding in a northerly direction in Tottenham Court Road, other than a pedal cycle or local bus, to proceed past the junction with Chenies Street between the hours of 8am and 7pm on Mondays to Saturdays.
- 4.7 No person shall cause any vehicle proceeding in a northerly direction in Tottenham Court Road, other than a pedal cycle or a local bus, to proceed past the junction with Howland Street between the hours of 8am and 7pm on Mondays to Saturdays.
- 4.8 No person shall cause any vehicle proceeding in a southerly direction in Tottenham Court Road, other than a pedal cycle or a local bus, to proceed past the junction with University Street between the hours of 8am and 7pm on Mondays to Saturdays.
- No person shall cause any vehicle proceeding in a southerly direction in Tottenham Court Road, other than a pedal cycle or a local bus, to proceed past the junction with Chenies Street between the hours of 8am and 7pm on Mondays to Saturdays.
- No person shall cause any vehicle proceeding in a southerly direction in Tottenham Court Road, other than a pedal cycle or a local bus, to proceed past the junction with Stephen Street between the hours of 8am and 7pm on Mondays to Saturdays.
- The restrictions set out in Articles 4.4 to 4.10 inclusive shall not apply in respect of a vehicle being used by or on behalf of the council for the purposes of waste collection or street cleansing.

## 5. Other exemptions

- Nothing in Article 4 shall apply in respect of;
- anything done with the permission of a police constable or traffic warden in uniform;
- a vehicle being used by the police, ambulance service or fire brigade in an emergency;

any person causing any vehicle to proceed in accordance with any restriction or requirement indicated by traffic signs placed pursuant to Section 66 or 67 of the Road Traffic Regulation Act 1984.
