CANFIELD GARDENS - removal of the north-easternmost 2.7 metre section of the permit holders parking place outside no. 65 Canfield Gardens and this section designated with a 24-hour prohibition on waiting. **FROGNAL LANE** – removal of a 5 metre section of the parking place opposite no. 18 Frognal Lane. **HONEYBOURNE ROAD** – removal of a 2.7 metre section of the parking place opposite no. 2 Honeybourne Road.

MILLMAN STREET – removal of a 2.7 metre section of the parking place outside Millman Court. **PRIORY ROAD** – 1) removal of the Car Club parking place opposite no. 85 Priory Road and this section designated with a 24-hour prohibition on waiting. 2) removal of the northernmost 3.2 metre section of the parking place outside no. 88 Priory Road.

REGENT'S PARK ROAD – removal of the northernmost 6.5 metre section of the permit holders / paid-for parking space opposite no. 108 Regent's Park Road.

TWISDEN ROAD – removal of a 2.7 metres section of the permit holders parking place opposite no. 4 Twisden Road.


There is a growing demand from residents living in high density dwellings, with limited space for sheltered and secure cycle parking within their properties.




The Council believes the introduction of secure cycle hangar parking facilities would encourage cycling within the borough especially in locations where high density dwellings are present.


