**3. The Categories of Personal Data, Special Category Data and Criminal Offence Data we collect and use**

The data collected will vary according to the needs of the case/service being delivered. We will not collect data that is not necessary for the delivery of the duty/service. Data collected may include any of the following:

- Names of people involved in the service request/case/investigation/activity
- Addresses and contact details of people involved in the service request/case/investigation/activity
- Date of Birth
- Employment details
- Qualification details
- Lifestyle/social circumstances/specific needs/vulnerabilities
- Visual images or recordings where required as part of service delivery or investigation
- Information in relation to notifiable infectious disease – name, address date of birth of case and household and non-household contacts, place of work or educational establishment, travel/visiting, ethnicity, recent activities/places visited/foods consumed
- Any other personal data that data subject provides voluntarily
- When commenting on a licensing application, their views and opinions about the license
- Personal data and criminal offence data about previous convictions, warnings and enforcement actions

**4. The purpose of the processing**

We are processing the data in to fulfil our legal and public duty obligations under various public protection legislation and so that we can effectively provide you with the services that we deliver which include the follow (non-exhaustive list)

- To undertake a range of statutory and non-statutory inspections and interventions within Camden businesses
- To coordinate, investigate and respond to complaints from citizens and other authorities relating to Camden businesses activities and Camden citizens
- To carry out investigations into reports of infectious disease and work-related illness in relation to Camden citizens and Camden based employees
- To enforce legislation to ensure Camden businesses are compliant with public protection and consumer protection legislation
- To investigate accidents, dangerous occurrences and deaths which occur in workplaces which Camden have a health and safety oversight for

To undertake enforcement action including prosecutions and related work as necessary

## 5. The legal basis for processing personal data

### a. Personal Data

- In respect of objectors to Sexual Entertainment Licenses, the release of their name and address to the applicant requires consent under art 6(1)(a) in accordance with Local Government (Miscellaneous Provisions) Act 1982, Schedule 3, para 10 (17)

- Art 9(2) (i) Public health (with a basis in law) with the Data Protection Act 2018 Schedule 1 Part 1 condition being Para 1 Employment, social security and social protection and Para 3 Public health

c. **The legal basis for processing Criminal Offence data-** The legal basis is the same as for personal data above and the Data Protection Act 2018 schedule 1 requirement is met by para 1 Employment, social security and social protection, Para 2 Health or social care purposes, para 3 Public health, and para 6 Statutory and government purposes with the underpinning law for all are set out in the Applicable Laws at the end of the Privacy Notice.

## 6. Law Enforcement Processing: We may prosecute for breaches of laws and regulations associated with each of the named regulatory categories listed in the Applicable Laws section at the end of the Privacy Notice.

The Data Protection Act 2018 Part 3 s35 requirement is met by the processing being necessary for the performance of a task carried out for law enforcement purposes by a competent authority. Sensitive data (special category data) meets the condition of being Strictly necessary and the Data Protection Act 2018 schedule 8 condition (for sensitive data) is met by as appropriate for each case:

- Para 1 necessary for judicial and statutory purposes – for reasons of substantial public interest;
- Para 2 necessary for the administration of justice;
- Para 3 necessary to protect the vital interests of the data subject or another individual;

- Para 6 necessary for legal claims;
- Para 7 necessary for when a court acts in its judicial capacity;
- Para 8 necessary for the purpose of preventing fraud.

- Where someone has made representations on a license (except a Sexual Entertainment Venue license) their name, address and contact details will be shared with the applicants for the purposes of the application including so they can discuss your objections with you and try to resolve them. They cannot use your details for any other purposes. If you want to object to this see 'exceptional circumstances' below.
- Where someone has made representations on a Sexual Entertainment Venue license their name and address will only be shared with the applicants with your consent and for the purposes of the application including so they can discuss your objections with you and try to resolve them.

The council may disclose relevant data to other local authorities to assist Camden in fulfilling its legal duties and delivering Public Tasks

We may undertake general data matching or data sharing in certain areas for the prevention or detection of crime such as with for example to HMRC. Trading Standards will share data with HMRC in relation to the sale and supply of illicit tobacco so that the HMRC can impose sanctions against seller and suppliers of illicit and non-duty paid tobacco.

## **8. Out of UK Transfers**

We will only transfer your personal data outside of the UK if you are located outside of the UK.

## **9. The retention period**

To ensure we are using and storing data in line with legal requirements, different types of records are governed by recommended periods of retention to ensure that data is being processed lawfully and fairly.

We will only retain your personal data, while it is relevant and necessary to do so; this depends upon the purpose of the processing. Generally, data is retained for a maximum of 6 years plus current year. However, legal documentation may be kept indefinitely in certain instances, such as investigations of work-related deaths or incidents of asbestos exposure. Retention periods are held on a central retention register at [LBC Retention Schedule and Disposal Policy](#)  
Data is stored in compliant password protected databases

## **10. What information is mandatory for you to provide and the consequences of not providing the information, and whether giving Personal Data is part of a statutory or contractual requirement or obligation.**

### **a. Generally**

Providing your name and address may be part of a legal requirement for example food business operators must provide details of their name and address on their food registration form; people suffering from notifiable diseases must provide their name address and date of birth; citizens may be asked to provide details of the names and address of persons having an interest in any land or property which is subject to regulatory controls. If you do not provide the details requested you may be subject to enforcement action for obstructing a process. Where this is the case, this will be explained to you. E.g. provision of name and address of business operators and license and permit holders.

Citizens making a request for service/making allegations of any legal breaches will need to provide their name address and contact details so that we can log the complaint and liaise effectively.

People making complaints/objections/supporting comments in respect of licensing applications need to provide a name, address and contact details.

People making an application for a license will need to provide the information specified in the relevant legislation which will include name and address (and age in some cases).

**b. Exceptional Circumstances and Redactions: people making objections or other comments in support of licensing applications apart from Sexual Entertainment Venue licenses.** Where you have made representations on a license (except a Sexual Entertainment Venue license) your name, address and contact details will be shared with the applicants for the purposes of the application including so they can discuss your objections with you and try to resolve them. They cannot use your details for any other purposes. If you want to object to

this there will need to be ‘exceptional circumstances’. This would include fear of intimidation or violence if their personal details, such as name and address, are divulged to the applicant. Where we consider that someone has a genuine and well-founded fear of intimidation and as a result of this may be deterred from making a representation, they may wish to consider alternative approaches. For instance, they could provide the relevant responsible authority with details of how they consider that the licensing objectives are being undermined so that the responsible authority can make representations if appropriate and justified. We may also decide to withhold some or all of the person’s personal details from the applicant, giving only minimal details (such as street name or general location within a street). However, withholding such details would only be considered where the circumstances justify such action. If making an application please provide details with supporting evidence where possible.

### **11. Automated Decision Making And Profiling.**

We are not using automated Decision Making or profiling to process your Personal Data  
Note: Automated Decision Making is where a computer makes the entire decision, there is no human involvement at all. Profiling is where there is automated processing which is intended to evaluate certain personal aspects of an individual, in particular to analyse or predict their behaviours, reliability etc.

### **12. Your Data Subject Rights**

You have the right to request a copy of the information we hold about you, the right to ask us to rectify, erase or restrict processing of your data, the right to ask for data portability, the right to object to automated decision making, and if we are relying on consent (which generally we are not here) the right to withdraw consent at any time.
